



Asphalt Field Technician I&II Training

Curriculum

This is on-line certification training for personnel performing NDOT Asphalt Field Technician I&II inspection.

The class consists of:

1. Pretest
2. Video Part 1 is approximately 1.5 hours.
3. Video Part 2 is approximately 2.25 hours.
4. Final Exam

Pretest

The pretest may be completed while watching the training videos, this is recommended. Save the completed pretest, as it must be submitted when requesting your final exam reservation date to your area Quality Assurance Manager (listed below). You must pass the pretest with 70% or better to take the final exam.

Videos

You can pause or restart the video and watch as many times as you like.

Final Exam

The final exam will be a proctored exam on Webex or scheduled in person. The exam is open book, open notes. You must always have an operational microphone and video camera during the Webex exam, no exception. You must pass the final exam with 80% or greater for certification, otherwise you must start back over with the training.

Summary

Here is a quick summary of what you need to do. Open the Pretest and save it to your desktop under your actual name as the filename. Then watch the videos at your own pace and fill out the pretest as you go, we think this is best. If you have passed with 70% or greater, you will be scheduled for a final exam on-line through Webex or scheduled in person. You must pass the final exam with 80% or greater. Good Luck!
