WAIVER OF DEDUCTION FOR NON-CONFORMING MATERIAL

CONSTRUCTION DIRECTIVE

BACKGROUND:

Subsection 105.03 of the NDOT Standard Specifications for Highway Construction Edition 2017 states that nonconforming material or work may be accepted and allowed to remain in place at a reduced cost. That reduction in cost is conveyed to the Contractor by a written notice (deduction letter) from the Engineer to the Contractor informing them of the amount of monetary deduction that will be imposed.

The deduction letter is typically developed, written, and reviewed by the Construction Division, and then forwarded to the Project Manager, District Construction Engineer and other NDOT stakeholder(s) for review. Following their review and any amendments, the deduction letter is sent by the Project Manager to the Contractor. This deduction is then codified in a Change Order in AASHTOWare. This process takes NDOT time and resources that correlate to a cost to the Department. This cost is estimated to be \$250.00.

POLICY:

Deductions that are calculated and found to be \$250.00 or less are to be waived as the cost to the department exceeds the amount being collected from the Contractor through the deduction. The deduction waiver for a singular noncompliant acceptance standard that is a part of a group or set of acceptance criteria (e.g., sublots and lots) for a material or item of work can be postponed until all of the acceptance criteria has been evaluated to determine if the sum of the deductions for that material or item of work exceeds \$250.00.

In the event that the reduction is \$250 or less, correspondence will be sent from the Construction Division to the Project Manager and other NDOT stakeholder(s) notifying them of the waiver. A letter will be sent to the Contractor from the Project Manager indicating the failing tests and the NDOT decision to forego the deduction. See the attached template notification letter.
