

## 2019 MADD Nebraska Court Monitoring Briefing

**Case Analysis for all 19 Counties: Adams, Buffalo, Cuming, Dakota, Dawson, Dodge, Douglas, Gage, Hall, Jefferson, Lancaster, Lincoln, Madison, Phelps, Platte, Red Willow, Saline, Sarpy and Wayne.**

Statewide there were 6,827 arrests recorded by NDOT – Office of Highway Safety in 2018. As of today, the 2019 arrest numbers are not available. MADD analyzed 1,544 DUI cases that occurred in 2019. This represents 23% of the total cases (when comparing to 2018 numbers). These cases were primarily misdemeanor charges, unless the individual was charged with a DUI 3<sup>rd</sup> .15+ or higher – those are considered felony offenses in the state of Nebraska.

## Ignition Interlock 2019

In Nebraska, ignition interlock installation became mandatory for all those convicted of DUI in 2013. Ignition interlocks save lives by requiring convicted drunk drivers to prove they are sober before their car will start. Ignition interlocks are proven effective — on average, ignition interlocks reduce repeat drunk driving offenses by 67 percent.
