Comparable Experience Log – Class A License

List only periods of employment, and corresponding periods of comparable work experience, for which you were serving at least half-time (at least an average of 20 hrs. or more per week). Depending on circumstances, the period of comparable experience may or may not be the same as the period of employment. You must document at least forty-eight (48) full months of experience, during the eight (8) year period from October 1, 2012 – December 31, 2020, *comparable (substantially similar) to work of an employed county highway or city street superintendent*. Work or service at less than half time each for two or more entities during the same period will count if, when combined, they total at least twenty (20) average hours per week.

The following detailed definitions and requirements pertain to comparable experience (from Regulations of the Board of Examiners, Title 425, Chapter 2):

003.04 STREET OR HIGHWAY SUPERINTENDING shall mean all of the following functions and duties:

- 003.04A Developing and annually updating long-range plans for highways, roads and streets based on needs of the county or municipality and coordinated with adjacent governmental units.
- 003.04B Developing annual programs for design, construction, and maintenance of highways, roads and streets of the county or municipality.
- 003.04C Developing annual budgets based on programmed projects and activities.
- 003.04D Implementing the capital improvements and maintenance activities provided in the approved plans, programs and budgets.
- 003.04E Managing personnel, contractors, and equipment in support of such planning, programming and implementation operations.

006.02D Qualifications – Prior Experience. The applicant either shall document sufficient experience as an employed superintendent or shall document comparable work experience.

006.02D2 The applicant had at least forty-eight (48) months of work experience that is comparable to the work experience of appointed and employed county highway superintendents and city street superintendents, on at least a half-time basis, in the preceding eight (8) years.

006.02D2(a) Such experience shall include performing work substantially similar to all of the superintendent duties defined in Subsection 003.04 of this rule, including managerial or supervisory responsibility over departments, sections or positions engaged in such comparable work.

006.02D2(b) The following shall constitute comparable work experience:

006.02D2(b)(i) Responsibility for federal, state, municipal or private industry highway, road or street improvement or maintenance projects, including serving as lead consultant, project manager, principal designer, design supervisor, budget and resources manager, or overall manager or administrator, for such projects.

006.02D2(b)(ii) Serving as an appointed and contracted consulting county highway or city street superintendent or engineer, or in a comparable capacity, including concurrent service for two or more jurisdictions, if such service included oversight or active advisory responsibility for substantially all aspects of street or highway superintending as enumerated in Subsection 003.04.

006.02D2(b)(iii) Training county highway or city street superintendents or engineers, or persons in comparable capacities.

006.02D2(b)(iv) Other comparable work experience as may be presented to the Board for its consideration.

Example 1: Henry Jones has been an engineer full-time with XYZ Consulting since 2011. From May 2015 through July 2020, he served as the appointed and contracted city street superintendent for 5 jurisdictions. His work as street superintendent for those five jurisdictions combined takes 20 hrs. per week on average. He fills out the Log rows for 2015 through 2020, and writes a description and comparability statement on page 7, thereby documenting at least 48 months of comparable work experience.

Example 2: Fred Smith is the managing partner of ABC Consulting. From May 2012 through the present, he has supervised a team of engineers who collectively spend more than 20 hrs. per week on average as appointed and contracted county highway superintendents. He fills out the Log rows for 2013 through 2020, and writes a description and comparability statement on page 7, thereby documenting at least 48 months of comparable work experience.

Example 3: Lucy McIntyre is the full-time Assistant Highway Superintendent for McClellan County. Though employed by the County, she does not qualify as the superintendent appointed for Incentive Funds purposes. From March 2015 through the present, she has been involved in all aspects of the county road program. She fills out the Log rows for 2016 through 2020, and writes a description and comparability statement on page 7, thereby documenting at least 48 months of comparable work experience.
