#### **Federal Projects**

Anna Lannin presented the following projects. The airport sponsors are requesting Commission approval for the CIP data sheets to be forwarded to the FAA, as required by state statutes. The FAA considers the requests for future federal funding as funds become available. No state funds are requested at this time.

<u>Alliance R-03</u> Scope: Rehabilitation of Runway 8/26 Total Estimated Cost: \$3,000,000

The existing Runway 8/26 bituminous PFC surface is over 15 years old and is in need of rehabilitation. The existing runway pavement section includes 1.5 inches of PFC (P-402) surface course on 3-inches of Bituminous (P-401) course over 9-10 inches of PCC (P-501) pavement. The existing Bituminous (P-401) is over 30 years old and needs to be removed. The project will include removing the existing 1.5 inch PFC (P-402) course and 3 inch Bituminous (P-401) course and installing a new 4-inch Bituminous (P-401) course with new pavement markings.

<u>Alliance C-04</u> Scope: Replace Taxiway and Runway Light Bases Total Estimated Cost: \$60,000

The existing MITL and Runway 8/26 MIRL lights were moved in 1997 in order to narrow up the taxiway and runway pavement surfaces, as part of the project new conduit, wire, bases, and lights were installed in the paved shoulders. Some of the light bases have moved from freeze-thaw operations and are in need of replacement. Due to the bases being located in paved surfaces it will require additional construction efforts to properly remove and replace the bases without

damaging the existing lighting system. The airport is requesting that this work occur under the FAA standard construction specifications to ensure the lighting system is protected and the bases are installed to proper FAA standards.

<u>Beatrice A-01</u> Scope: Reconstruct Apron; Reconstruct, Offset and Light Taxiway C Total Estimated Cost: \$1,401,700

The existing apron and Taxiway C has a pavement section consisting of approximately 3" of asphalt overlay over approximately 8" of PCC Pavement. A portion of the apron was overlaid with 2" of asphalt in 2004 and sealcoat treatment applied to Taxiway C and the apron in 2010. The underlying concrete pavement is showing signs of Akali Silica Reaction (ASR) and has for several years. The underlying pavement is expanding and causing heaving in the surface. The asphalt is approaching the end of its useful life and reconstruction will be required. New concrete pavement, on rubbilized existing concrete will provide the airport with a good structural paving section with little maintenance for years. Taxiway C will be offset as not to have direct access to Runway 18/36 from the parking apron.

Beatrice

Scope: Taxiway C Medium Intensity Taxiway Lights Total Estimated Cost: \$361,800

The existing Medium Intensity Taxiway Lights (MITL) are over 20 years old and at the end of their useful life. With the reconstruction of Taxiway C (new location between Runway 18/36 and parallel Taxiway A) and the apron, the lighting system will have a new configuration and will require lighting adjustments. Since the lights are at the end of their useful life, new lights are proposed with the new configuration.

Beatrice

Scope: Rotating Beacon with Tip-down Tower Total Estimated Cost: \$74,400

The existing beacon is nearing the end of its useful life and difficult to maintain and get parts. A new rotating airport beacon on a tilt-town tower for ease in maintenance is proposed.

Motion by Commissioner Anderson to approve the CIP data sheets and forward them to the FAA. Second by Commissioner Cook. Roll call vote. All voted aye. Motion carried.

# State Aid Requests

The following projects were presented to the Commission with a request for a state grant.

<u>Gothenburg</u> Scope: Repair Pavement Sections Total Estimated Cost: \$100,000 State Grant Request: \$90,000

#### Representative: Robert Mann

There are several high concrete cracking in the runway and taxiway pavement which exhibit differential movement. The heaving in the concrete is an annual event, but each year the problem gets worse. The heaving is a serious safety issue. The airport has made great progress in reducing its indebted-ness but can't afford a project of this size. Without help from the State the concrete will not be replaced because there are other pressing projects.

<u>Nebraska City X-05</u> Scope: Pave Parallel Taxiway to Runway 15 FAA Eligible Section: from connecting taxiway to runway 15 turnaround Total Estimated Cost: \$1,606,160 State Grant Request: \$32,123 Representatives: Arnold Ehlers, Tom Trumble, Diane Hofer

The projected cost to the airport has increased from \$229,303 to \$342,258. This projected increase is due to changes in FAA standards as well as greater site prep dictated by the results of soil testing. Documentation of these increases is included with this application. This application is for that portion of the project ELIGIBLE for FAA participation.

This project received funding during the October 2014 commission meeting but the funds expired due to delays in the project. The Authority is requesting a reallocation of state funding with the current cost estimates.

<u>Nebraska City X-05</u> Scope: Pave Parallel Taxiway to Runway 15 Ineligible Section: From Turnaround to Runway End Total Estimated Cost: \$199,782 State Grant Request: \$100,000 Representatives: Arnold Ehlers, Tom Trumble, Diane Hofer

A portion of the parallel taxiway is ineligible for federal funding. The FAA has stated that this section of taxiway must be completed when the parallel taxiway is paved or the airport will be required to shorten their runway to the FAA eligible length. The Airport Authority and the State has substantial investments in the runway extensions and the Authority desire to retain the runway at its present length. This application is for that portion of the project INELIGIBLE for FAA participation.

<u>Norfolk M-01</u> Scope: Rehabilitate Storm Sewer Drainage System Total Estimated Cost: \$2,210,000 State Grant Request: \$44,200 Representatives: Terri Wachter, Tom Trumble, Diane Hofer

The existing storm sewer was installed in the mid 1940's and is worn out and failing. Objective is to rehabilitate the storm water drainage system by removing and reconstructing storm water

inlets and piping system. This project will enhance safety and serve to prolong the integrity of the runways and taxiway paving system.

<u>NDA</u> Scope: Pavement Preservation Program Total Estimated Cost: \$50,000

The Pavement Preservation Program is used to assist airports with seal coats and crack repair. There are several airports that are not eligible for federal funding and rely on this program to extend the life of their asphalt pavements.

<u>Wallace</u> Scope: Geotechnical Investigation of Pavement and Subgrade Total Estimated Cost: \$3,000

The Wallace Municipal Airport experienced flooding earlier this year. The airport sponsor has been in contact with FEMA and NEMA to request funding to repair damage caused by the flooding. These agencies need additional documentation on the damages in the form of a geotechnical investigation as much of the damage is expected to be in the sub-grade under the pavement.

## **Funding Discussion**

The commission discussed the available funds (\$184,401.77) and the project requests (\$319,323). The first funding option proposed to fully fund the Nebraska City eligible section, Norfolk, Wallace, and partially fund the Gothenburg request and Pavement Preservation Program. The representative from Nebraska City objected due to the negative impact on their airport if the FAA ineligible section remained unfunded. Commissioner Anderson worked to move funds from other projects to the Nebraska City project until there was confirmation from Nebraska City that they could live with the results. The final allocations are as follows:

#### **Department Report**

At our last Commission meeting I advised you concerning increasing revenue for our cash funded department and that I couldn't give you the details until a later date. Those details follow. In our search for ways to increase revenue we have a legislative proposal at the Governor's Policy Research Office (PRO) which would redirect the NE aircraft sales and use tax from the general fund to the Aeronautics cash fund. We await PRO's answer (coming next week) as to whether or not this proposal will be presented to Governor Ricketts for his approval as a legislative bill.

We have been in contact with the NE Department of Revenue concerning this proposal as it would require them to redo the form used in enforcement of collecting the tax. At their request and included in the legislative proposal, would be the addition of aircraft registration to include a fee of \$35/aircraft to cover expenses. Registration would be accomplished through our department and would require hiring an additional part time person.

If our legislative proposal is approved and passed by the legislature, we anticipate additional revenue in the neighborhood of \$750,000 per year. Some years it would be less while other years it might be more. This increase in cash funds would be used for the state grant program, to support the federal match on airport improvement projects for communities unable to do so and to support ongoing expenses of this department.

As we go forward with this proposal it will require a commitment from the Commission. The commitment is to promote this legislative proposal with your senatorial contacts, your friends and other persons who would like to see this department continue to support our system of airports with monies generated by aviation for aviation purposes.

Included with this report is a listing of NE airport funding needs and our aviation gas tax revenue (our largest single source of income). Please notice FY13-14 was \$43,500 below the previous FY12-13 while FY14-15 was \$100,121 below FY13-14. Aviation gas tax revenue continues to decline and other sources of monies need to be discovered to keep our department on the leading edge of assisting and mentoring our great system of public use airports.

# Nebraska Airport Funding Needs September 2015

The Nebraska Department of Aeronautics compiled the following lists of airport projects to illustrate the current infrastructure and funding needs of the airports in our state. The airport sponsors were not contacted specifically for their current needs but rather the needs were gathered from the annual update of the Nebraska Airport Capital Improvement Plan and the continuous coordination needed for the federal grant program.

Federal funds for airport improvements are received through the Federal Airport Improvement Program. Eligible airports can receive grants to cover up to 90% of project costs. Federal projects are being delayed or abandoned because the local airport sponsor cannot finance 10% of the project costs.

#### Potential FY2015 Federal funded projects that were delayed because of limited matching funds

Dollar amounts shown are the estimated matching funds for the project.

- 1. Albion: pave the access road and construct parking for the new terminal building (\$10,900)
- 2. Stuart-Atkinson: partial parallel taxiway (\$43,000)
- 3. Central City: construct new T-hangar (\$59,975)
- 4. Curtis: apron and taxiway rehabilitation (\$65,350)
- 5. Fairbury: construct new shop hangar (\$185,500)
- 6. Hyannis (Grant County): airport layout plan (\$20,000)
- 7. Red Cloud: construct new T-hangar (\$54,200)
- 8. Superior: install navigational aids (PAPI, REIL, beacon)(\$23,000)

#### Potential FY2016 Federal funded projects that are being delayed because of limited matching funds

Dollar amounts shown are the estimated matching funds for the project.

- 1. Aurora: pave the access road and construct parking (\$25,000)
- 2. Crete: replace T-hangar (\$270,000)
- 3. Garden County (Oshkosh): pavement maintenance (\$28,000)
- 4. Rushville: acquire snow removal equipment (\$26,550)
- 5. Thedford: construct T-hangar(\$180,000)
- 6. Wallace: airport layout plan (\$20,000)

This list may grow as we move into FY2016 and financial commitments must be made to keep the projects on schedule.

To the eligible to receive federal funding, the airport must be listed in the Nation Plan of Integrated Airport Systems (NPIAS). There are currently 81 public-use airports in Nebraska of which 73 are listed in the NPIAS. The remaining airports are not eligible for federal funds and historically have depended on state funds for airport improvements. These airports include:

- 1. Arapahoe
- 2. Bloomfield
- 3. Genoa
- 4. Gothenburg
- 5. Hay Springs
- 6. North Omaha
- 7. South Sioux City
- 8. Trenton

As part of a new program implemented in 2015, general aviation airports must also be classified in the NPIAS in order to received federal entitlement funds, which is the source of funds for this type of airport. In the current NPIAS, three Nebraska airports are unclassified.

- 1. Bassett, Rock County Airport
- 2. Chappell, Billy G Ray Field
- 3. Sargent

There are currently eleven Nebraska airports that are not in a position to receive federal funds.

Public-use airports can request state grant funds for airside improvements. These grants can also cover up to 90% of the project costs. Airport sponsors are aware of the limited amount of available funds and are no longer requesting state grants for their improvements. The Department of Aeronautics has seen a deterioration of the airport system and an increased need for reconstruction due to the delay of timely rehabilitation projects.
