



- Sets forth guidelines & requirements for accommodating utility facilities within State Highway Property
- In process of completely revamping the policy





ACCOMMODATION POLICY

<u>Current Step</u> Review & comment phase

• Internal & FHWA concurrent review

Next Step

Implementation phase

• Internal implementation & Stakeholder outreach



POLICY – KEY CHANGES

- Depth of bury by facility type
- Update casing requirements for steel pipelines
- Outlines NDOT utility coordination process
- Expand construction and maintenance requirements
- Identifies construction plan and 'As-Installed' plan requirements
- Addresses change in ownership and abandoned or out of service facilities
- Broadband chapter



PROJECT LEVEL UPDATES



UTILITY QUESTIONNAIRE

- Receive via email from NDOT Utility Coordinator
- Action by Utility Company required:
 - Review and provide information for <u>existing facility locations</u>
 - Review existing locations for <u>construction conflicts</u>, both temporary and permanent conflicts
- Transmit responses and supporting documentation back to NDOT
- NDOT will track unresponsive utility companies & continue to follow up



CONFLICT ANALYSIS PROCESS

- Utility Company will perform Conflict Analysis
 - Review for conflicts with:
 - Final construction limits of construction, ROW, ditch grading
 - Temporary construction drives, access crossings, phasing
 - NDOT will review analysis and work with Utility Company
- If relocations are required, Utility Company will provide relocation information:
 - Scope of work
 - Detailed cost estimate
 - Schedule of relocation work



RELOCATION PROCESS

- NDOT will review and provide comments on relocation plans and detailed cost estimate
 - Will be incorporated into the agreement
- Master (Blanket) Agreement or Utility Project Agreement
 - Only if relocation is reimbursable
- Letter of Authorization
 - Every relocation



2024 GOALS

- Implement Utility Accommodation Policy
- Identify utility conflicts early
- Coordinate utility relocations to be complete by construction start
- Professional development of coordinator staff
- 2024 District Utility Program Meetings October



ACTIVITIES VS. CONFLICTS

When we say	Think about
Access Crossings – Contractor ~Pipes or Temp. Bridge	Cranes and large equipment Impacts or proximity to overhead power Piling for temporary bridge
Shoo-flys – Traffic	In addition to access crossings Additional fill Impacts to pedestals, pull boxes, overhead power, etc.
Grade beam on pile	Cranes Impacts or proximity to overhead power
Over-excavation	Possibility on any project Most likely at culverts and locations of known muck



ACTIVITIES VS. CONFLICTS

When we say	Think about
Concrete Box Culverts	Sheet pile driven at wingwalls Impacts to buried lines Impacts or proximity to overhead power Temporary shoring on phased construction
Culvert Replacements – Phased construction	Potential for temporary shoring Need room (H & V) to construct end treatments
Culvert Replacements – Jacking	Large jacking pits - ~50'x100', not shown in plans Temporary excavation down to flowline to construct Need room (H & V) to construct end treatments



ACTIVITIES VS. CONFLICTS

When we say	Think about
Temporary Roads & Drives	Can require grading and ditch work Similar impacts to permanent construction
Guardrail	Posts can impact underground facilities
Sidewalk & ADA work	Pavement removal Shallow service lines
Curb Inlets	3 ft – 6 ft deep, in most cases Cast in place inlets require extra room for form work


