<u>Presentation of 428 NAC 2 Proposed Changes – Brad Reid, NDOT Policy & Practical Design.</u>
Mr. Reid and Mr. Owen provided the board with an update.

NBCS 428 NAC 2 Proposed Changes – Roger Figard, NBCS Chairperson. Chairman Figard provided the board with an update. The board staff will work with NDOT to develop a list of proposed changes.

NDOT Practical Design Case Study – Nathan Sorben and Brad Reid. Chairman Figard announced there would not be a presentation today, and that it will be continued into the future.

At 9:47 a.m., the Board heard the <u>NDOT request for a Relaxation</u> for Project No. NH-75-2(186), C.N. 22756, US-75 Southbound Chandler Road to I-480. *(The hearing was held in an informal format, NDOT having declined the option of a formal hearing.)* The request is for a Relaxation of the 428 NAC 2 – 001.02U, Resurfacing, Restoration and Rehabilitation (3R) Municipal – State Highway System – Vertical Clearance, on an Expressway/Principal Arterial State Highway, US-75, as specified in NDOT letter of July 6, 2020. Mr. Wehling and Mr. Garbers presented the request and provided an updated PowerPoint presentation. No one appeared in opposition. The hearing concluded at 10:00 a.m. The Board then considered the request.

Mr. Wootton moved to grant the NDOT relaxation, in view of the peculiar, special or unique local situation presented whereby the application of a specific Minimum Design Standard would work a special hardship. Ms. Kramer seconded the motion. Members Keegan, Krager, Kramer, Litchfield, Weander, Wootton and Figard voted YES. Members Gerrard, Syslo and Tagge were absent. The motion carried with the required six (6) votes.

At 10:02 a.m., the Board heard the <u>NDOT request for a Relaxation</u> for Project No. STP-S13K(103), C.N. 12704, Weeping Water Spur. *(The hearing was held in an informal format, NDOT having declined the option of a formal hearing.)* The request is for a Relaxation of the 428 NAC 2 – 001.02G, New and Reconstructed Rural – State Highway System – Clear Bridge Width Structure Number SS13 K 00087, on a Major Arterial/Major Collector State Highway, State Spur 13K, in Cass County, as specified in NDOT letter of June 24, 2020. Mr. McCullough and Mr. Lux presented the request. No one appeared in opposition. The hearing concluded at 10:22 a.m. The Board then considered the request.

Mr. Wootton moved to grant the NDOT relaxation, in view of the peculiar, special or unique local situation presented whereby the application of a specific Minimum Design Standard would work a special hardship. Mr. Litchfield seconded the motion. Members Keegan, Krager, Kramer, Litchfield, Weander, Wootton and Figard voted YES. Members Gerrard, Syslo and Tagge were absent. The motion carried with the required six (6) votes.

- Implementation of LB82 (2019) and other Statutes; and changes to the Board's 428 NAC Regulations and Operating Procedures. Mr. Schultz provided the board with an update on LB82 (2019), which replaces the annual filing of the One- and Six-Year Plan or Program, and the former Standardized System of Annual Reporting (SSAR), with the Nebraska Board of Public Roads Classifications and Standards (NBCS). In its place, all counties and municipalities, and NDOT, are required to file an Annual Certification of Program Compliance and Signing Resolution with the Board, by October 31, 2020 for the counties and municipalities, and July 31, 2020 for NDOT. Letters and forms will be mailed to all county and municipal clerks in mid-August, and to NDOT following this meeting.
