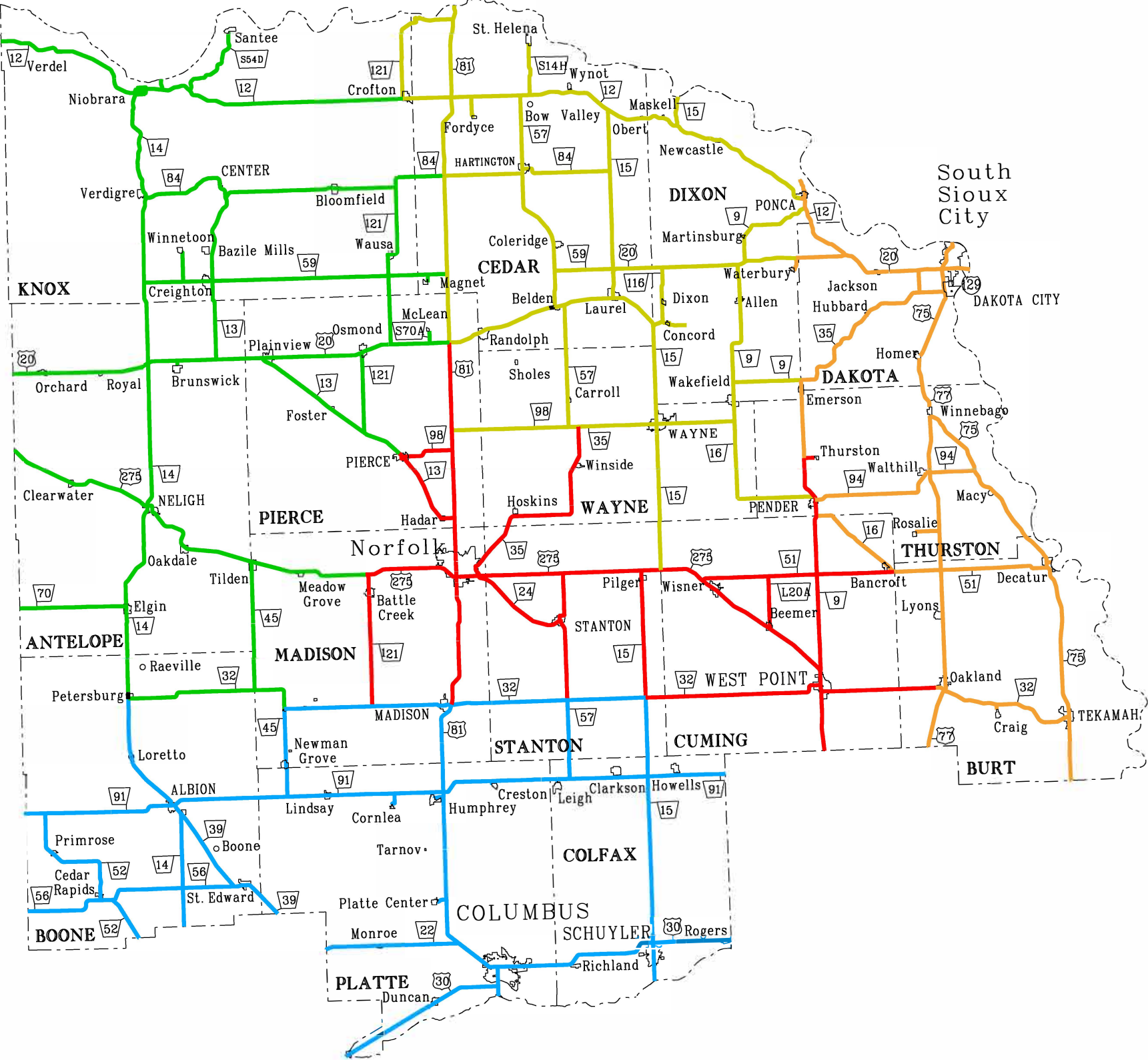

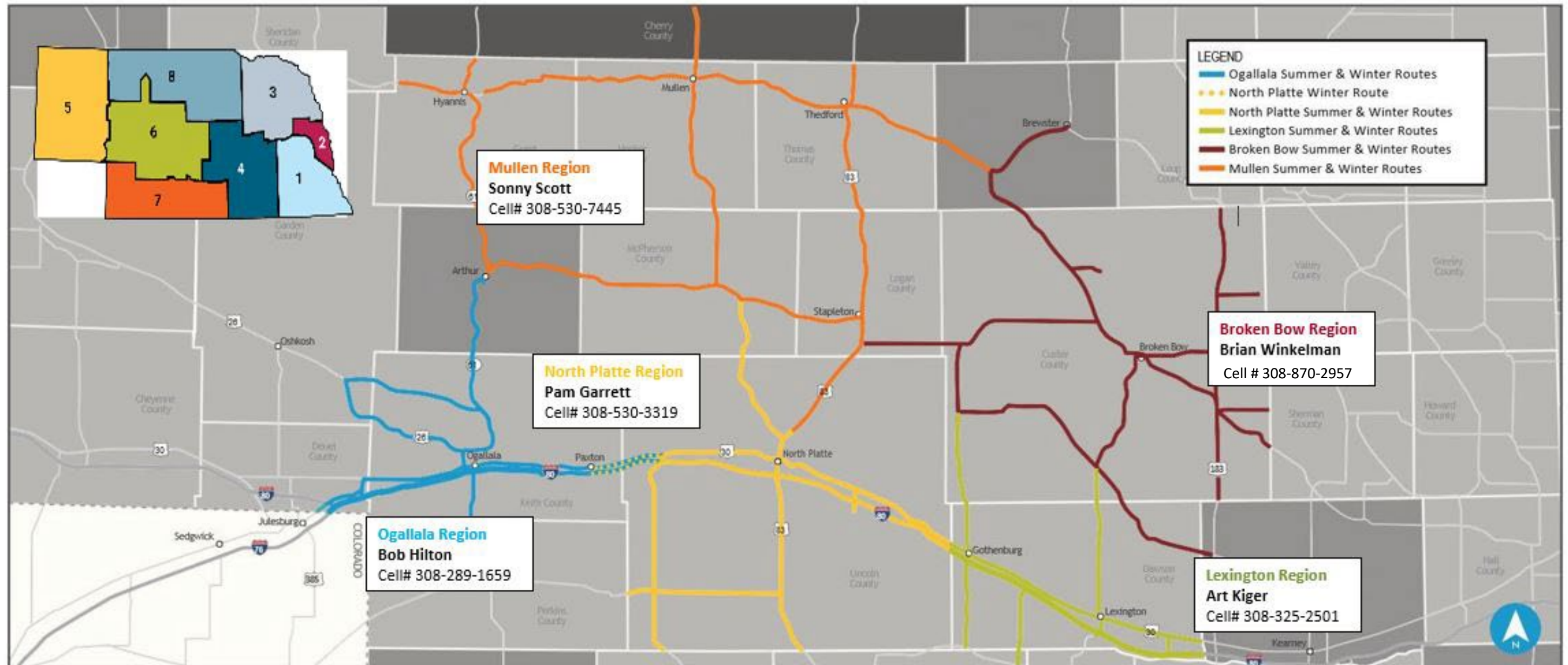

## NDOT CONTACTS & COVERAGE MAP

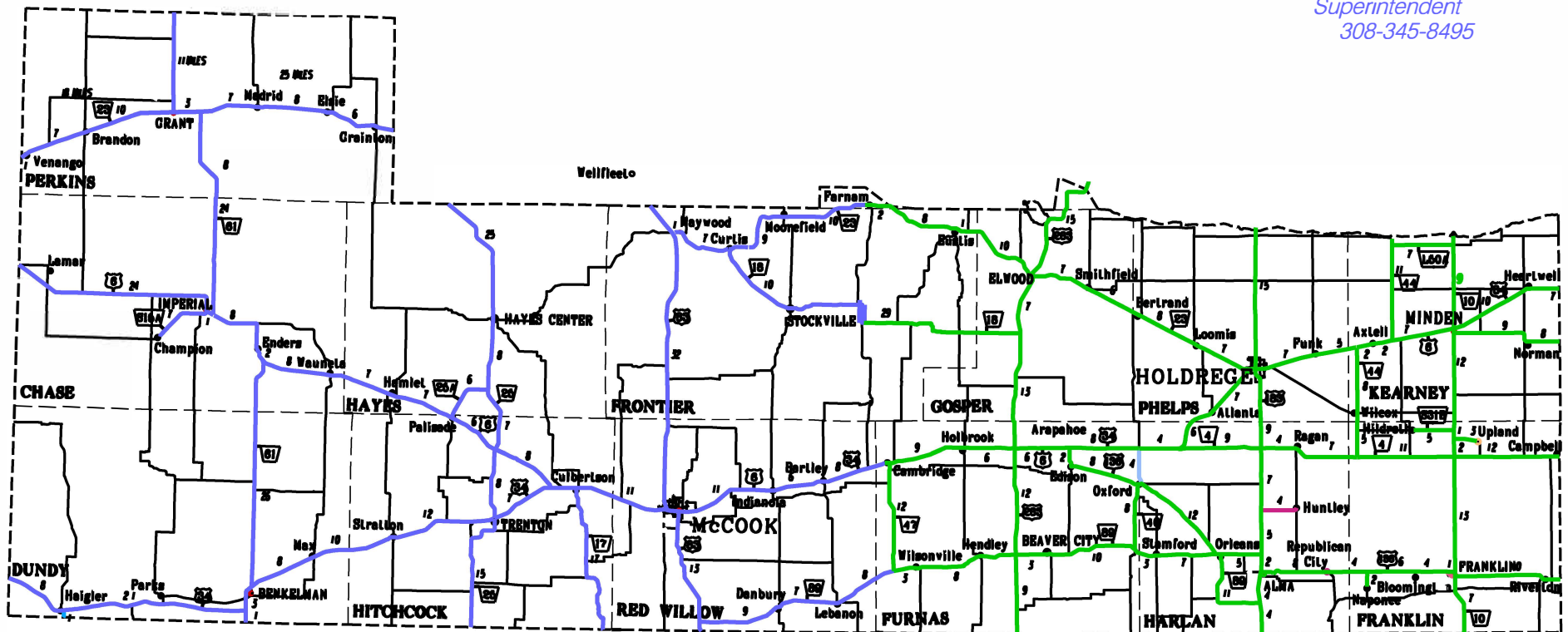
