

Minor Categorical Exclusion for Sign Installation and Replacement

Under the Memorandum of Understanding Between Federal Highway Administration, Nebraska Division and the Nebraska Department of Transportation, State Assumption of Responsibility for Categorical Exclusions, as authorized by 23 USC §326 (herein referred to as the CE MOU and CE Assignment), the Federal Highway Administration (FHWA) has delegated approval authority of certain Categorical Exclusion (CE) actions to the Nebraska Department of Transportation (NDOT).

NDOT has developed this programmatic Minor Categorical Exclusion (MCE) to document review and approval of certain activities listed under 23 CFR 771.117(c) that, based on past experiences with similar actions, do not involve significant environmental impacts to natural, social and economic resources. NDOT has determined that project-specific NEPA documents and technical resource reviews are not required for actions that comply with the terms and conditions of this MCE. Activities addressed by this MCE, which are not part of a larger undertaking, shall be administered in accordance with the following criteria to satisfy NDOT's CE assignment responsibilities.

This MCE for Sign Installation and Replacement addresses activities classified under 23 CFR 771.117(c)(8), which also meet the criteria for 23 CFR 771.117(c)(22).

Scope of Work-Sign Installation and Replacement

Maintenance and replacement of highway signs on existing poles
Installing new signs within existing fill material locations, with any fill material disturbances not to exceed the depth of fill material
Traffic control necessary for the sign improvements, provided no road closures exceeding 24 hours will occur
Other (please explain):

Based on the nature of *Sign Installation and Replacement* activities, NDOT does not anticipate negative impacts to natural, cultural, historic or recreational resources; these activities do not negatively impact air, noise, water quality, hazardous materials, or travel patterns, and do not present any negative cumulative impacts. NDOT has determined that *Sign Installation and Replacement* activities do not affect listed species, historic properties, wetlands or Waters of the U.S., nor do they use Section 4(f) properties. NDOT experience has demonstrated that these types of activities do not generate controversy on environmental grounds.

Application of this MCE is dependent upon adherence with the following commitments. These Commitments shall be included in project-specific "Green-Sheets" and/or project agreement documents.

To eliminate possible impacts to whooping cranes:

 Construction activities will not occur during whooping crane migration periods (spring migration: March 6 – April 29; and fall migration: October 9 – November 15).

OR

- If construction activities occur during whooping crane migration periods (spring migration: March 6 April 29; and fall migration: October 9 November 15), NDOT trained personnel, or a qualified biologist, will conduct surveys according to protocol (prior to the start of daily construction activities). If species are present the District will notify the Contractor to stop work within ½-mile of the whooping crane and follow the protocol to determine when work can resume (also not initiate work if species is found in the morning survey). Options for resuming work may include but are not limited to:
 - Construction activities are limited to the hours from 10:00 a.m. to 4:00 p.m. (CST) during the migration period, unless morning survey indicates whooping cranes are not present.
 - If a whooping crane is observed during the survey within ½ mile of the project, but departs
 the area (further than ½ mile from the project) then work can resume. Document this
 departure according to protocol.

To eliminate possible impacts to nesting interior least terns or piping plover:

• Any work occurring within ¼-mile of perennial waters should be done between August 15-Apri I. If work cannot be done during this time, steps shall be taken to avoid disturbing terns and plovers. While working, the contractor shall park their work vehicles(s) in a manner that would block the visibility of any stream, river, sandpit, or water-body. Work is to be conducted as quickly and quietly as possible.

To eliminate possible indirect impacts to species sensitive to nighttime lights:

- Lighting outside fully developed, urban areas shall be installed in such a way as to direct the lighting to the roadway.
- Except for work within fully developed, urbanized areas, nighttime work with lights is prohibited.

To avoid impacts to undetected archeological resources:

• Any and all ground disturbance is limited to fill material locations, with any fill material disturbances not to exceed the depth of fill material.

To avoid impacts to the community:

- Any closures to the roadway will be for short duration (less than 24 hours) with an alternate access route adequately signed. Emergency services shall be given adequate notice of any closures.
- Access must be maintained at all times to any and all public parks, recreation areas and wildlife refuges.

To avoid unanticipated impacts:

- The Contractor shall not stage, store, waste or stockpile materials and equipment in undisturbed locations, or in known/potential wetlands and/or known/potential streams that exhibit a clear "bed and bank" channel. Potential wetland areas consist of any area that is known to pond water, swampy areas or areas supporting known wetland vegetation or areas where there is a distinct difference in vegetation (at lower elevations) from the surrounding upland areas.
- Staging and/or stockpiling areas for construction supplies and Contractor's equipment shall be located in areas that are frequently disturbed such as, but not limited to, field entrances, crop fields, abandoned roadway, farmsteads and roads. If this is not possible, the contractor

shall coordinate with NDOT Environmental with a site plan showing the desired staging/stockpile location(s), which will be sited in such a way as to avoid impacting protected species.

To avoid hazardous material concerns:

- Any items that may contain hazardous materials, such as lead-based paint or mercury, must be properly handled and disposed of as outlined in the standard specifications.
- If contaminated soils and/or water or hazardous materials are encountered, the Contractor shall follow the NDOT Unexpected Waste Action Plan (2015). The Contractor is required by NDOT's Standard Specification section 107 (legal relations and responsibilities to the public) to handle and dispose of contaminated material in accordance with applicable laws.

Individual projects actions approved under this MCE shall be reviewed to ensure unusual circumstances as outlined by 23 CFR 771.117(b) do not exist. If an unusual circumstance is identified, a project-specific NEPA document, in compliance with NDOT's Environmental Procedure Manual (EPM) and Nebraska Categorical Exclusion (NECE) guidelines shall be developed to approve the action.

This MCE is consistent with the Statewide Long Range Plan, the Statewide Transportation Improvement Program (STIP), and applicable Metropolitan or Rural Planning Organizations' Transportation Improvement Programs (TIPs) and Long Range Transportation Plans, and is exempt from regional air quality conformity determinations (40 CFR parts 51 and 93).

Use of this MCE is only allowed if all criteria set forth herein are met.
