### MINUTES Nebraska Aeronautics Commission October 25, 2019

The Nebraska Aeronautics Commission held their regular meeting at the department's offices, Lincoln, Nebraska. Chairperson Tom Trumble called the meeting to order at 1:00 p.m. CDT. Commissioners Terri Wachter, Diana Smith, Michael Cook and Dick Trail were in attendance. Also present were Director Ann B. Richart, Planning/Programming Division Manager Anna Lannin and Deputy Director Andre Aman.

#### **Approval of Minutes**

#### **Division Report**

- Kyle Schneweis, Director of NDOT, P.E., could not attend this Aeronautics Commission Meeting because of schedule conflict with Highway Commission Meeting.
- Richart goal to visit all 80 public-use airports during her first year on the job.
  - o So far made it to 31
  - Learn that the residents of Nebraska really appreciate their airport and understand its importance

  - There would be adjustment to positions and responsibilities in NDOT Aeronautics Division
  - o Richart hoping to announce the changes in December Commission Meeting.
- Airport Licensing

#### **Federal Aid Project Requests**

Anna Lannin presented the following projects for Commission approval to forward to the FAA with a request for funding, as required by state statutes. The FAA considers the request for future federal funding as funds become available. No state funds are requested at this time.

#### Albion R-01

Scope: Crack & Joint Seal With Pavement Marking

Total Estimated Cost: \$235,825

This project involves sealing all the concrete joints on the airport, including the runway, parallel taxiway and apron. Included in this project is the repainting of the pavement markings. The latest pavement evaluation was conducted by the Nebraska DOT Division of Aeronautics in September of 2017. The entire airport is rated as "Good" with PCIs of 88 to 98. This project would repair any cracks and joint damage. Keeping joints and cracks sealed will improve the lifespan of the pavement. The pavement was constructed about 20 years ago in 1999.

#### Hebron R-01

Scope: Runway, Taxiway, Apron Rehabilitation; Crack & Joint Seal, Panel Replacement, Re-Mark Total Estimated Cost: \$350,000

The concrete runway, taxiway and apron are in good condition except for the marking are fading, joint sealant is separating or overflowing in joints; and there are several cracked panels. The project will include new markings, select panel replacement, and joints to be resealed. This is a cost-effective approach in extending the life of the runway, taxiway and apron pavements.

Motion by Commissioner Diana Smith to approve the CIP data sheets and forward them to the FAA. Second by Commissioner Michael Cook. Roll call vote. All voted aye. Motion carried.

#### **State Aid Project Requests**

#### Blair SA

Scope: Extension of Taxilane for Additional Hangars

Requested Funds: \$152,190

Representatives: Geary Combs, Chairperson of Blair Airport Authority

The airport is working on a proposed project for a private developer to construct a new  $100 \times 100$  ft. hangar. The current taxi lane will need to be extended to allow full access to the new hangar. Once this project is completed there will not be any taxi lane for additional corporate type hangars. We are working on a second hangar construction project for a second additional hangar Without the taxi lane being extended there is no chance of making the second project happen.

#### Bloomfield SA

Scope: Runway Repairs Requested Funds: \$45,000

Representative: Steve Barney, Airport Manager at Bloomfield Airport Authority

The Airport Authority is requesting additional state aid for the airport Runway 14/32. Due to the spring flooding that occurred at the airport, they had to do an additional 770 feet of crack repair and additional flood damage repair on the runway. There is a contract with Blackwoods Company.

#### Creighton SA

Scope: Obstruction Removal Requested Funds: \$11,367

Representative: Anna Lannin, NDOT Aeronautics Division

At the last inspection on June 27, 2019, numerous trees violated the State Licensing Standards. The Authority is requesting a grant to remove the violating trees.

#### David City SA

Scope: Pave Connecting Taxiway

Requested Funds: \$87,300

Representative: Eric Johnson, Kirkham Michael

The proposed taxiway will connect the paved taxilanes to the shop hangar. The taxiway would provide access to the runway from the hangar occupied by Storm Aeronautics and future Thangar development. The current turf taxiway is not an all-weather surface. This project will allow operations to the hangar during wet and winter conditions.

#### Hartington SA

Scope: Obstruction Removal Requested Funds: \$10,170

Representative: Anna Lannin, NDOT Aeronautics Division

During the last licensing inspection, June 13, 2019, numerous trees were identified as violating the State Licensing Standards. The bid from Plumbing & Electric is to permanently remove all trees that are currently in violation as well as trees that will be in violation in the near future. The Authority also included letters granting permission from all landowners.

#### Hebron SA

Scope: Obstruction Removal Requested Funds: \$32,400

Representative: Anna Lannin, NDOT Aeronautics Division

The airport licensing inspection on June 20, 2019 identified trees as being in violation of the licensing due to their height and/or proximity to the airport. A tree survey was completed to identify which trees were in violation. Trees in violation will be removed or topped for licensing compliance and Part 77 Airspace requirements.

#### Hebron SA

Scope: Replace Beacon Requested Funds: \$45,000

Representative: Deb Craig, Airport Authority and Tiffany Thompson, Kirkham Michael

The beacon is continually having problems and it is hard to find replacement parts due to the age of the equipment. The Authority proposed to relocate the beacon and install a new beacon with a tip-down pole.

#### Loup City SA

Scope: Obstruction Removal Requested Funds: \$4,185

Representative: Anna Lannin, NDOT Aeronautics Division

During the last licensing inspection, June 5, 2019, numerous trees were identified as violating the State Licensing Standards. The Authority requests a grant to remove the trees.

#### South Sioux City SA

Scope: Obstruction Removal Requested Funds: \$34,200

Representative: Anna Lannin, NDOT Aeronautics Division

During the last licensing inspection, June 13, 2019, numerous trees were identified as violating the State Licensing Standards. The Authority requests a grant to remove the trees.

#### Tecumseh SA

Scope: Obstruction Removal Requested Funds: \$7,902

Representative: Anna Lannin, NDOT Aeronautics Division

Dave Lehnert, NDOT Aeronautics Division, inspected the airport on June 20, 2019. It is requested the Airport Authority clean up brush, trees and crops within the primary surface area that violate the State Licensing Standards. The work is already started, but help is needed with the funding to complete the project.

#### Thedford SA

Scope: Replace Beacon Requested Funds: \$45,000

Representative: Ron Masten, Secretary of Thomas County Airport Authority

A federal project is planned to replace the runway and taxiway lights at the airport. The Authority proposed to install a new beacon with the lighting project. The beacon is not included in the scope of the federal project.

#### Wahoo SA

Scope: Obstruction Removal Requested Funds: \$14,400

Representative: Anna Lannin, NDOT Aeronautics Division

In the summer of 2019 NDOT, Aeronautics Division conducted their airport inspection. It was determined from the survey work that multiple trees are in conflict with the transition zone of Runway 13. These trees are mature and likely have not changed in height for several years. Contact has been made with the landowner and a plan is being developed to address the removal of the trees in conflict. Trees would be removed while crops were out of the adjoined fields. Clean up includes stump removal, final grading and planting of disturbed areas.

# NDOT Division of Aeronautics (NDA) Scope: Pavement Preservation Program

Requested Funds: \$250,000

The request will fund the Divisions Pavement Preservation Program which provides seal coats and crack repairs for General Aviation Airports.

Motion by Commissioner Michael Cook to approve the State Aid Project Requests. Second by Commissioner Terri Wachter. Roll call vote. All voted aye. Motion carried.
