GENERAL

In accordance with Nebraska Consultants' Competitive Negotiation Act (Neb. Rev. Stat. §81-1702), the Brooks Act (40 USC 1101), and 23 CFR 172.5, the State of Nebraska, Department of Transportation (NDOT), is issuing a Request for Qualifications (RFQ) for Spring 2024 MS Projects. Qualified consultants are invited to submit a statement of qualifications as outlined below. All consultants interested in providing professional services for NDOT are strongly encouraged to review NDOT's template <u>Standard Professional Services</u> <u>Agreement</u>, <u>Sample Fees and Payments Exhibit</u>, and <u>Insurance Requirements for Professional Service Providers</u> prior to responding to this RFQ. By submitting a statement of qualifications in response to this RFQ, Consultant, and all subconsultants, agree to meet the substantive requirements of these documents. These documents can be found on NDOT's website. An agreement will not be executed unless consultant provides a current overhead (indirect cost rate) schedule and proof of meeting the insurance requirements in the form of an <u>Insurance ACORD</u>. SCOPE OF SERVICES

A. OVERVIEW:

NDOT has developed a list of 11 projects scheduled for completion over the next few years. These projects vary in complexity/duration and are detailed in the accompanying project list (Attachment A). The project list provides a description of the project, approximate schedule, and the range of services anticipated for each project. Not all projects will require services from all Standard Work Categories listed above.

Instead of developing a scope of service for each project individually, NDOT is attaching the basic scopes of services for each type of service needed, utilizing the project list to specify which services are likely needed for each project. All scopes of services identified below are provided in Attachment B.

B. <u>SCOPES OF SERVICES</u>

The scope of services for each project may include:

- 1. Project List (Attachment A).
- 2. Environmental Services (Attachment B1)
- 3. Roadway Design (Attachment B2)
- 4. Bridge Design (Attachment B3)
- 5. Bridge and Roadway Hydraulics (Attachment B4)

- 7. Survey (Attachment B6)
- 8. Public Involvement (Attachment B7)

C. SCHEDULE (IF APPLICABLE):

The currently planned fiscal year for construction is provided for each project in Attachment A. A more refined schedule will be developed during the detailed scoping and negotiation for each project.

DETAILS

It is anticipated that thirteen (13) consultants will be short-listed for interviews, with eleven (11) consultants to be awarded a contract for one of the projects. The evaluation criteria to be used for the short-listing and final selection is outlined below. The payment method for the contract may be Lump Sum, Cost Plus Fixed Fee, or Specific Rates of Compensation.

NDOT reserves the right to abandon or terminate any contract at any time and either re-advertise services or utilize its own forces. NDOT also reserves the right to accomplish services for future phases on all projects with the selected consultant, select another consultant, or utilize its own forces.

NDOT will <u>not</u> hold a briefing. All information is contained within this RFQ and on NDOT's website. If additional information is deemed necessary, it will be posted on the same web page as this RFQ and will be labeled as an update. Consultants interested in this RFQ are responsible for checking for updated information.

Interested consultants must be certified by NDOT or have a completed certification form on file with NDOT prior to the deadline identified in the Schedule of Activities. Please submit your Drug-Free Workplace Policy (DF Policy) separate from the response to this RFQ (DF Policy Example). The DF Policy is a one-time submittal to NDOT. Please do not re-submit unless your DF Policy has changed or you never have previously submitted a DF Policy. While the DF Policy is not a submittal requirement, all consultants must have an acceptable DF Policy on file prior to the deadline identified in the Schedule of Activities. EVALUATION CRITERIA

A. QUALIFICATIONS (50 PTS)

- 1. Qualifications of the project manager(s) and key team members to perform the services described in the Scope of Services for the project(s) of interest.
- 2. Consultant's knowledge and experience with the environmental process anticipated for projects in this RFQ.

3. Qualifications and capability of key subconsultants to perform the services outlined in this RFQ for the project(s) of interest.

B. UNDERSTANDING AND APPROACH OF THE SERVICES PROVIDED (30 PTS)

- 1. Consultant has demonstrated understanding of the key elements of the work
- 2. Consultant has demonstrated they will allocate appropriate and sufficient staff resources or qualified subconsultants to meet project objectives and schedules.
- 3. Consultant provided logical approach to the project development process
- 4. Consultant has provided comparable projects for which they have been involved

C. PERFORMANCE DATA (20 PTS)

- 1. Cooperation, communication, quality, and timeliness of deliverables with NDOT on previous projects. If the consultant's team has no experience with NDOT, the consultant should include three (3) references in their response, including contact information, that have directly been involved with similar projects and services.
- 2. For those projects that require environmental work, the consultant's team has authored Categorical Exclusion (CE), Wetland/404, and other environmental technical documents with minimal revision.

Final Selection

The Department will conduct interviews discussions with the top ranked (short-listed) firms to further understand the evaluation criteria responses, and to hear how each firm can best meet the needs of NDOT related to these services. A final tally of evaluation criteria scoring will occur at the conclusion of interview discussions. NDOT will coordinate interview discussions with each short-listed firm to occur within the scheduled dates shown below.

NOTE – Shortlisted Firms may be asked to provide verification that they and all subconsultants have submitted their indirect cost rates and certifications for their latest fiscal year. Latest fiscal year means the last fiscal year with an end date no more than 6 months in the past.

SUBMITTAL OF QUALIFICATIONS

All information must be received by the deadline identified in the Schedule of Activities. No exceptions to this deadline will be given.

Business Opportunities page. Please "reduce file size" of PDF before submitting.

Submittals are to include the following in the order given below:

- 1. Front cover to include the consultant, subconsultants (if applicable), and number and title of the RFQ.
- 2. A letter of interest not to exceed one (1) page.
- 3. RFQ-2408 Project Interest Form not to exceed one (1) page.
- 4. Organizational Chart not to exceed one (1) page.
- 5. A narrative responding to the established evaluation factors not to exceed five (5) pages.
- 6. A maximum of five (5) pages of additional supportive material such as charts, tables, resumes, or photos.
- 7. NDOT Form 498, "Architect, Engineer, & Related Services Supplement to Statement of Qualifications" (MS Word version) not to exceed six (6) pages for the consultant and six (6) pages for each subconsultant. A separate NDOT Form 498 must be submitted for each subconsultant to be used.

Additional submittal requirements are:

- 1. All material in the submittal must be formatted for 8½ x 11 paper, single or double spaced.
- 2. Submittal covers and dividers between the sections are allowed and not included in the page limit.

INTERVIEWS

NDOT will make every effort to post the short-listed consultants on NDOT's website prior to the deadline identified in the Schedule of Activities. Interview discussions will last approximately 15 minutes.

NDOT will conduct interview discussions via telephone with the short-listed consultants promptly after determination of the shortlist.

Upon completion of scoring and approval of the Deputy Director, NDOT will post the final selections on NDOT's website prior to the deadline identified in the Schedule of Activities, or as soon as possible.
