### Construction to Begin on the N-370 - Omaha Project

**March 8, 2024, (Omaha, Neb.)** — On Monday, March 11, weather permitting, work will begin for the Nebraska Highway 370 (N-370) - Omaha project.

The project consists of bridge and pavement repairs to N-50, locally known as Millard Avenue, starting near the N-50 bridge over N-370 and extending north near the intersection of N-50 and U.S. Highway 275 (US-275)/N-92, known locally as L Street.

Improvements on this project consist of concrete replacement, repairs, and sealing, milling and resurfacing, bridge repairs, replacing guardrail, and constructing and modifying curb ramps along N-50. Major bridge work will occur at the N-50 bridge over Papillion Creek, as described above, and N-370. During major bridge repair work, N-50 may occasionally be limited to one lane in each direction.

Minor bridge work will occur at the N-50 bridge over I-80 and the BNSF railroad crossing. The N-370 and Interstate 80 (I-80) ramps will undergo concrete repairs, and joint and crack sealing. For minor bridge repair work, intermittent day and overnight lane closures can be expected. Movement restrictions can be expected at Chandler Road, Echo Hills Drive, Josephine Street, Harrison Street, Drexel Street, Madison Street, Stony Brook Boulevard, N-50/Millard Avenue, and U Street. During this, detours will be provided.

Additionally, N-50 will be widened at its intersection with Harrison Street to create dual northbound and southbound left turn lanes. This work includes pavement removal and construction, culvert removal and construction, grading, sidewalk removal and construction, and traffic signal removal and replacement. This work is anticipated to begin in May 2024.

This work is necessary to enhance safety, accessibility, and efficiency for all road users. The project addresses deteriorating road conditions and optimizes traffic flow at intersections, ultimately contributing to safer and more reliable transportation infrastructure.
