

MINUTES
Nebraska Aeronautics Commission
December 5, 2025

The Nebraska Aeronautics Commission held their regular meeting at the NDOT Central Complex Auditorium, 1500 Nebraska Parkway, Lincoln, Nebraska. The legal ad was published in the November 25th edition of the Lincoln Journal Star and is posted on <https://dot.nebraska.gov/aeronautics>. The Commission Book and Public Meetings Act were also posted on the website.

Chairperson Scott Tarry called the meeting to order at 1:05 p.m. CDT.

Commissioners Jon Large, Tom Trumble and Michael Cook attended in person. Commissioner Edward Dunn was absent. Also present were Director Jeremy Borrell, Engineering Division Manager Anna Lannin, Deputy Director/Legal Counsel Andre Aman, Jamie Mikkleson, Tiffany Thompson, and Davey Jones Engineering Division

Public Comment

No public comment was received.

Approval of Minutes

Motion by Commissioner Michael Cook to approve the minutes of the October 24, 2025, meeting. Second by Commissioner Tom Trumble. Roll call vote. All voted aye. Motion carried.

Aeronautics Director's Report

Director, Jeremy Borrell, reported that onboarding for the BlackCat system is progressing as planned, with initial access to the testing site granted and full access for airport sponsors, commissioners, consultants, and FAA partners anticipated in the coming months. Airport call letters have been distributed with a January deadline, including requests for Airport of the Year and Project of the Year submissions. The Aviation Art Contest is underway with a submission deadline of January 16. Staff continue working with airports to update basedaircraft.com in preparation for the upcoming NPIAS snapshot, and the Central Region successfully met the Part 139 PCR reporting deadline.

Director Borrell also discussed the NASAO Airport Partner Membership Program, noting low participation and encouraging airports to activate and use their logins, as program utilization will be evaluated for continuation. Progress is being made on the Crack and Joint Pilot Program, with procurement underway prior to selecting participating airports. Additionally, a statewide hangar study will be conducted over the coming year, including a survey supported by an intern, and airports were encouraged to participate to ensure accurate data. The Director noted that the first draft of the Secure Drone Purchasing Act List (LB660) will be submitted next week and that a follow-up email will be sent to airports with reminders and to solicit locations for future commission meetings.

Andre then provided clarification on how flight check funds are recovered during the federal grant closure process and updated the Commissioners on Lexington's and Seward's hangar loans. Both projects required the use of the FY25 IIJA funds to pay a portion of the project; therefore, their requested hangar loan amount will be reduced.

Closed Project Report

Correction of State Grant Allocation- Scottsbluff Matching Grant

A correction to the October 2025 State Grant Allocation for the Scottsbluff Matching Grant was presented. A request was made that Scottsbluff's 2025 State Grant allocation be reduced from \$37,700, as noted during the October 2025 meeting, to \$21,500. The calculation was correct on the State Grant application; however, it was incorrectly noted during the meeting.

Motion by Commissioner Michael Cook to approve the Director's recommendation of changing the amount from \$37,700 to \$21,500. Second by Commissioner Tom Trumble. Roll call vote. All

voted aye. Motion carried.

Anna Lannin presented an update on current state grants. No commission action was required.

State Reimbursable Agreement for Flight Check Update

Tiffany Thompson presented an update on the State Reimbursable Agreement for flight checks. No commission action was required.

Federal Project Requests

The following projects were provided to the Commission for their review and approval prior to forwarding them to the FAA with requests for funding, as required by State Statutes. The FAA considers the request for future federal funding as funds become available. No state funds are requested at this time.

Beatrice E01

Scope: SRE Equipment

Total Estimated Cost: \$700,000

The existing snow removal equipment is at the age where maintenance is expensive and at times unreliable. A new SRE will make snow removal more efficient and reliable without concerns of untimely breakdowns.

Beatrice G06

Scope: Runway 18/36 & Runway 14/32 Markings

Total Estimated Cost: \$707,000

The existing runway markings will be reaching the end of their useful life and in need of re-marking.

Beatrice M05

Scope: Jet A Fuel Facility

Total Estimated Cost: \$910,000

The existing below ground Jet A Fuel Facility is reaching the end of its useful life. A new above ground Jet A Fuel Facility will provide better reliability and reduce ongoing maintenance costs.

Minden G03

Scope: Construct New AWOS III P/T

Total Estimated Cost: \$384,000

The airport currently does not have a weather monitoring system. The airport needs to install a weather monitoring system to improve aviation operational safety for medical, agricultural, and GA

flight operations. The airport proposes installing a new AWOS III P/T weather monitoring system to improve airport operational safety.

North Platte X08

Scope: Widen Taxiway Charlie
Total Estimated Cost: \$3,809,530

The project scope includes widening parallel Taxiway Charlie from 35' to 50' to accommodate Taxiway Design Group (TDG) 3 aircraft. Improvements include concrete paving, markings, edge lighting, and subdrainage piping. The existing Taxiway Charlie was constructed with an offset crown so that when widened to 50' the crown will be aligned with the taxiway centerline.

Motion by Commissioner Michael Cook to approve the CIP data sheets and forward them to the FAA. Second by Commissioner Tom Trumble. Roll call vote. All voted aye. Motion carried.

Election of Chairperson for 2026


