

Know the law and keep your kids safe.

- Children up to age eight must ride correctly secured in a federally-approved child safety seat.
- Children ages 0-18 must ride secured in a safety belt or child safety seat.
- Children shall be buckled in a rear-facing car seat, in the back seat, until age 2.
- Buckle all children age 13 and under in the back seat. Airbags can kill young children riding in the front seat.
- Buckle up each trip—every trip!

Car seats reduce the risk of fatal injury in cars by 71 percent for infants and 54 percent for toddlers. In SUVs, pickups and vans, they reduce the risk by 58 percent for infants and 59 percent for toddlers.

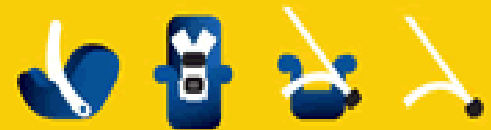

Make a difference

Join the more than 300 child passenger safety (CPS) technicians and instructors in our state. Techs hail from hospitals, health departments, police and fire departments and safety advocates. Most of the CPS techs are volunteers and their common bond is that they care deeply about kids and their community.

CPS technicians, mostly parents and volunteers, enjoy working together in the community at events to assist families, making sure children are in the right seat and it's used correctly!

Communities need more volunteers to support the inspection stations and check-up events.

Class schedule is: typically three 8 hour days; lunch and a snack are provided; and a 4 hour check event on the last day.

How to get trained

The national standardized child passenger safety technician certification course is 3-4 days long. It combines classroom instructions, and hands-on course work with car seats and vehicles. Best of all, the community safety seat check event gives you real hands-on experience and allows new techs the opportunity to demonstrate proper car seat installation and parent education.

You must attend the full training. Upon successful completion you will receive certification. Your CPS certification is good for two years and requires renewal, through CEU's and seat checks, every two years.
