REMARKS FROM THE CHAIR

- Commissioner Wolford: No additional remarks.
- Question entered from Commissioner Hawks: County commissioners have heard that the bridge program for counties is going away—can you speak to that?
 - Director Kramer: Yes, the County Bridge Match Program is a result of the funding from the Transportation Innovation Act (funds transferred from state to NDOT). Legislature required \$8 million of state funding to be used on county system. We support the program—we don't support using state funds to support the program. How do we solve the need? Over 380 projects have been done, but those left are not small projects. Fully expect it to be addressed as a funding bill—the need is there but we don't support it coming from state funds.
