### **NDOT to Host Public Open House Meetings May 7 and 13 for US-75 Corridor Study, N-370 to I-80 Project**

**April 23, 2026 (Omaha, Neb.)** — The Nebraska Department of Transportation (NDOT) is holding a public open house regarding the U.S. Highway 75 (US-75) Corridor Study, which evaluates approximately seven miles of US-75 from just south of Nebraska Highway 370 (N-370) to Interstate 80 (I-80) in Omaha and Bellevue, Nebraska.

NDOT is studying how to improve roadway condition, traffic flow and safety on this stretch of US-75. The study will look at current and future traffic, road and bridge conditions, and potential improvements along US-75 and at interchanges with N-370, Cornhusker Road, Chandler Road, Q Street, L Street and F Street. It also includes early design work and an environmental review that will help identify a recommended alternative and guide future projects for detailed design and construction.

As part of this process, NDOT is seeking public input on the initial alternatives being considered for US-75 and its interchanges. This feedback will help the team understand community priorities and shape the alternatives as the study progresses. Please join us:
