


SAFE VEHICLE POSITIONING TRAINING TIP


<u>Safe vehicle positioning</u> is a Traffic Incident Management (TIM) best practice to tactically position responder vehicles for on-scene protection during incident response and allow for safe traffic flow.

Reminders:

- Use larger vehicles for blocking upstream of the incident and leave room for other vehicles to safely access patients for transport and vehicles for recovery and clearance.
- Use lane +1 blocking to give responders room to work, when appropriate.
- Use MUTCD-compliant temporary traffic control (signs, cones) to establish a safe workspace.



Angled block; consider temporarily blocking additional lanes (lane +1) to protect the workspace.



DISTRICT 5 COALITION NEWS: KIMBALL TRAINING EXERCISE

Agenda topic at the July 29th Statewide Virtual Meeting!

Kimball Police Department hosted a large-scale, multi-agency mass casualty exercise on May 31, staged at the Kimball Regional Airport. The scenario simulated a complex traffic incident involving a school bus with children, a semi-truck, a passenger vehicle and an impaired driver, resulting in multiple injuries and one fatality.



Exercises simulating traffic incidents can be organized and executed by anyone! Lean on area TIM trainers and regional emergency managers to work together and make the most of local expertise and resources. A Training Exercise Worksheet is available on the Nebraska TIM website here to guide you through step-by-step exercise planning considerations. All disciplines should participate to improve interagency collaboration and preparedness.

Establish exercise goals & objectives with TIM top of mind:

- **Unified Command** Demonstrate multi-agency establishment and management of command for coordinated decision-making and effective scene management.
- Interagency Coordination Demonstrate effective identification of roles, responsibilities and resources from other disciplines that can be used to improve response and clearance.
- Vehicle Positioning Demonstrate knowledge of safe vehicle positioning as resources arrive.
- Quick Clearance Demonstrate knowledge & use of quick clearance strategies like early notification of key resources (e.g., traffic control support, towing/recovery, etc.) and moving crashed vehicles out of travel lanes with push bumpers.



DISTRICT 3 COALITION KICKOFF!

Stakeholders in the Nebraska TIM Program's District 3 collaborated at their first coalition meeting on June 10 in Norfolk, NE. The coalition has been established by Nebraska Department of Transportation District 3 Operations & Maintenance Manager Tim Koenig and Nebraska State Patrol Troop B Lieutenant Ben Brakenhoff. They are both TIM Trainers and are passionate about strengthening safety culture in Norfolk and the surrounding areas as area transportation needs change – like US-275 becoming a four-lane expressway facility.



When should you consider establishing a coalition, or hosting a coalition meeting? Crash after-action reviews, construction projects/corridor expansion and safety concerns (institutional, training gaps or high-crash locations) are all good reasons for multidisciplinary groups to meet and collaborate. If you have ideas on how TIM, operations or safety can be improved, plan a coalition meeting to strategize the best next steps for your area.

Who should be involved in coalition meetings? All disciplines should be involved, including law enforcement, fire, EMS,

emergency management, emergency communications, towing professionals, roadway owners, state, county and city staff, and others, to improve response to traffic incidents. Who are you working with regularly on traffic incidents? Who is passionate about traffic safety? Invite those people to participate!
