1.	Can I put an all of the areas or none clause on my bid?	The contractor may put an all or none clause on their Cost proposal bid sheet, but since the ROW mowing areas are being bid out as individual contracts, the contractor would need to be the low bidder in all three District 6 mowing areas to be awarded all three contracts. If a bidder bids in this manner, note NDOT would not be able to award to this vendor in any way should they be the low for one or two of the areas due to their own stipulation in their bid. Also, should a bidder be awarded on an all or none basis and make a determination at a later date that they can no longer mow in one or two of the three areas, NDOT would rebid all three (3) areas due to this bidder's own stipulation of all or none.
