**Notice of Calendar Year 2023 mailings from the Nebraska Department of Transportation (NDOT) that require an on-time response. There will be three (3) mailings. Failure to respond may result in the loss of Highway Allocation and Incentive Payment Funds.** If you do not receive the mailings via the US Post Office, please call (leave a message any time day or night) or email us.

**The 1<sup>st</sup> mailing called “Annual City Lane Mile Report” goes out mid-March of 2023.**

If you don't receive it by April 14<sup>th</sup>, call 402-479-3695, or email [ndot.mrecmhelp@nebraska.gov](mailto:ndot.mrecmhelp@nebraska.gov)

**Filing Deadline:** The filing deadline is July 31, 2023, no exceptions will be made.

**The 2<sup>nd</sup> mailing called “Annual Certification of Program Compliance” goes out July 26, 2023.** If you don't receive it by August 4<sup>th</sup>, call 402-479-4586, or

email [ndot.blshelp@nebraska.gov](mailto:ndot.blshelp@nebraska.gov)

**Filing Deadline:** The filing deadline is October 31, 2023, no exceptions can be granted. *(If we do not receive the documents by October 31, 2023, the distribution of Highway-User Revenue to the municipality may be suspended.)*

**The 3<sup>rd</sup> mailing called “Year-End Certification of City Street Superintendent for**

**Determining the Incentive Payment” for calendar year 2023, goes out October 18, 2023.** If

you don't receive it by October 27<sup>th</sup>, call 402-479-4586, or email [ndot.blshelp@nebraska.gov](mailto:ndot.blshelp@nebraska.gov)

**Filing Deadline:** The filing deadline is December 31, 2023, no exceptions can be granted. *(If we do not receive the documents by December 31, 2023, the municipality will not receive an Incentive Payment in February 2024.)*
