NDOT Project: NH-75-2(181) Parker St – Fort St., Omaha; CN 22647

Dear Citizen:

Enclosed is updated information regarding the proposed *Parker St – Fort St., Omaha* project. The Nebraska Department of Transportation (NDOT) is planning to improve approximately 2.47 miles of U.S. Highway 75 (US-75) as well as repair and paint several structures located along US-75. The timeline for the proposed project has been updated and construction could now begin as early as summer of 2023 and be completed by winter of 2024.

Previous outreach materials stated that temporary closures would be required for portions of US-75 as well as several structures along US-75, and that designated detours would be provided. Detours were anticipated to be in place for approximately 30-45 calendar days per structure. After further review, the anticipated detour lengths have been extended. The Hamilton Street bridge detour is now anticipated to be in place for up to 160 calendar days. The detour for the Parker Street bridge would be in place for up to 90 calendar days. Binney Street, Bristol Street, and Sprague Street bridge detours are now anticipated to be in place for up to 70 calendar days. No closure is anticipated for Lake Street or Ames Street.

Pedestrian access would be maintained during the Parker Street, Binney Street, Bristol Street, and Sprague Street bridge detours. An ADA accessible shuttle would be utilized for the Hamilton Street bridge detour. Previous materials stated the shuttle would be available for pedestrian traffic from 6:00 AM to 8:00 PM. The shuttle schedule would be modified from 6:00 AM to 9:00 PM to accommodate area businesses and programs.

All other information previously presented to the public remains the same.
