## NEBRASKA DEPARTMENT OF TRANSPORTATION NOTICE OF HIGHWAY IMPROVEMENT PROJECTS

## Douglas Co Line - N-64

NH-275-7(208); C.N. 22844

Identified as **Douglas Co Line – N-64**, the proposed project would improve approximately 6.79 miles of U.S. Highway 275 (US-275) in Douglas County.

The proposed project would begin at approximately mile marker (MM) 156.93 and extend southeast to approximately MM 163.55. Construction may begin and/or end approximately 500 feet ahead of or beyond the actual project limits to accommodate transitioning the pavement.

The purpose of this proposed project is to preserve the transportation asset, improve the reliability of the transportation system and perpetuate the mobility of the traveling public. The need for the proposed project is based on the current condition of the existing roadway.

Proposed improvements on this project would consist of concrete pavement repair, milling and resurfacing asphalt shoulders, and joint and crack sealing.

The proposed project would not require the acquisition of additional property rights. Access to adjacent properties would be maintained but may be limited at times due to phasing requirements. No wetland and/or other water resource impacts are anticipated.

Construction of the proposed project is tentatively scheduled to begin in spring 2024 with anticipated completion by winter 2024.

The proposed project would be constructed primarily under traffic with lane closures controlled by appropriate traffic control devices and practices;

however, temporary overnight ramp closures would be required. Alternate routes would need to be utilized during these short-term closures.

The following ramps would be closed at varying times throughout construction; not all at once.

- US-275 northbound off-ramp to N-36
- N-36 on-ramp to northbound US-275
- US-275 southbound off-ramp to N-36
- N-36 on-ramp to southbound US-275
- US-275 northbound off-ramp to N-64
- N-64 on-ramp to northbound US-275
- US-275 southbound off-ramp to N-64
- N-64 on-ramp to southbound US-275
