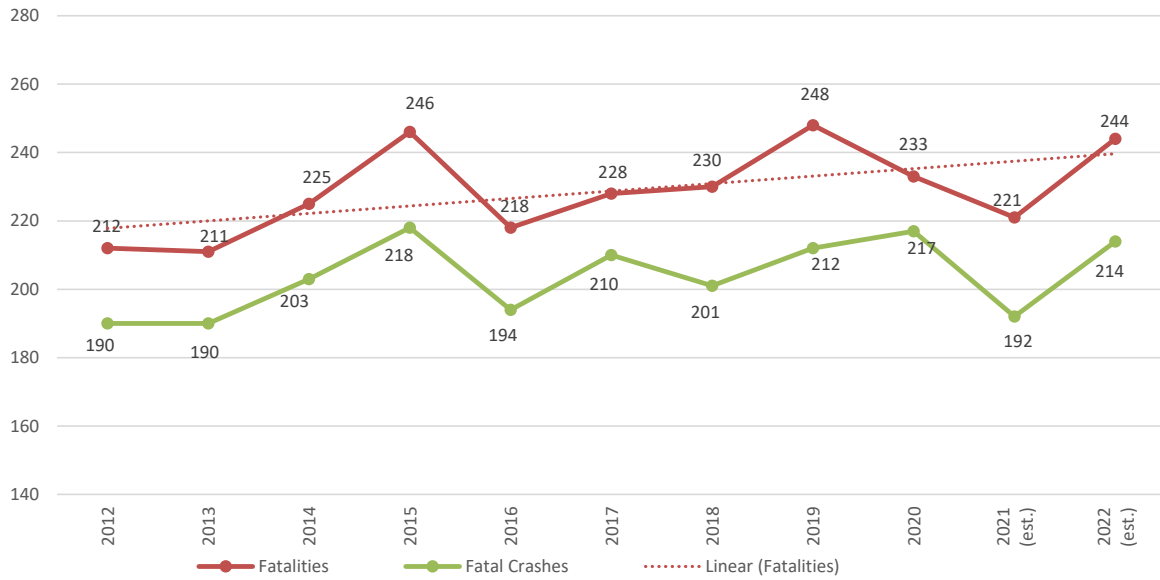

- \* January 1, 1985 LEGAL DRINKING AGE RAISED TO 21
- \* September 6, 1985 SAFETY BELT LAW (Driver/Secondary/\$25.00)
- \* January 1, 1986 PROOF OF INSURANCE AT TIME OF REGISTRATION
- \* December 1, 1986 SAFETY BELT LAW REPEALED
- \* April 28, 1987 INTERSTATE SPEED LIMIT INCREASED (55 MPH TO 65 MPH)
- \* January 1, 1989 MANDATORY MOTORCYCLE HELMET LAW
- \* July 10, 1990 ENHANCED CHILD PASSENGER PROTECTION LAW (Less than 40 lbs.)
- \* January 1, 1993 NEW SAFETY BELT LAW (Driver/Frt Passenger/Secondary/\$25.00)
- \* January 1, 1993 ADMINISTRATIVE LICENSE REVOCATION (ALR) LAW
- \* January 1, 1994 .02 BAC (ZERO TOLERANCE) UNDER 21 DRIVERS
- \* June 1, 1996 INTERSTATE SPEED LIMIT INCREASED (65 MPH TO 75 MPH)
- \* September 1, 1996 STATE AND SECONDARY ROAD SPEED INCREASES
- \* January 1, 1999 GRADUATED LICENSING LAW
- \* August 28, 1999 OPEN CONTAINER LAW
- \* July 13, 2000 EXPANDED CHILD PASSENGER RESTRAINT LAW
- \* September 1, 2001 .08 BAC LAW
- \* January 1, 2002 RACIAL PROFILING - TRAFFIC STOP REPORTING
- \* July 20, 2002 EXPANDED CHILD PASSENGER RESTRAINT LAW THRU AGE 5
- \* July 16, 2004 EXPANDED CHILD PASSENGER RESTRAINT LAW THRU AGE 17
- \* July 16, 2004 PROHIBIT PASSENGERS IN CARGO AREA OF PICKUP THRU AGE 17
- \* September 4, 2005 ENHANCED PENALTIES FOR REPEAT DUI OFFENDERS (.16 BAC)
- \* July 14, 2006 ENHANCED PENALTIES FOR REPEAT DUI OFFENDERS (.15 BAC)
- \* January 1, 2008 POP, LEARNER'S, AND SCHOOL PERMIT ENHANCEMENT
- \* January 1, 2008 UNDERAGE "DRAM SHOP" LAW
- \* January 1, 2009 IGNITION INTERLOCK LAW
- \* July 15, 2010 BANNED TEXTING WHILE DRIVING (Secondary Offense) \$200.00 Fine
- \* January 1, 2012 ENHANCED IGNITION INTERLOCK LAW
- \* January 1, 2013 ENHANCED IGNITION INTERLOCK LAW - (mandatory 45 day license suspension)
